WE DO NOT PROVIDE HEALTHCARE SERVICES. IF YOU ARE A PATIENT, THE TERMS AND POLICIES REGARDING THE HEALTHCARE SERVICES YOU RECEIVE, INCLUDING PRIVACY AND THE HANDLING OF YOUR DATA, ARE GOVERNED BY THE TERMS BETWEEN YOU AND YOUR HEALTHCARE PROVIDER AND YOUR PROVIDER'S PRIVACY POLICY OR NOTICE OF PRIVACY PRACTICES, AS APPLICABLE.

### I. INTRODUCTION

Nefro Health ("Nefro," "we," "our," or "us") respects and is committed to protecting your privacy. This Privacy Notice ("Privacy Notice") describes the types of information Nefro collects from you or that you may provide when you access and use the website owned and operated by Nefro at [www.nefrohealth.com](http://www.nefrohealth.com), (the "Website"). In this Privacy Notice, "we", "our", "us", and "Nefro" collectively refer to Nefro. The terms "you" and "yours" refer to the person using the Website.

Use of the Website is governed by this Privacy Notice and our Terms and Conditions. We encourage you to read this Privacy Notice in its entirety before using the Website. By using the Website, you acknowledge that you have read and agree to this Privacy Notice. This Privacy Notice is incorporated into our Terms and Conditions. All capitalized terms used in this Privacy Notice but not defined herein have the meanings assigned to them in the Terms and Conditions.

This Privacy Notice may change from time to time (see "Revisions to our Privacy Notice" below). Your use of the Website after we make changes is deemed to be acceptance of those changes, so please check this Privacy Notice periodically for updates. If any term in this Privacy Notice is unacceptable to you, please do not access or use the Website or provide any Personal Information (as defined herein) to Nefro.

Our Website may be linked on other websites or mobile applications, or may contain links to other websites or mobile applications. This Privacy Notice does not apply to information collected by any third party, including through any application or content (including advertising) that may link to, be embedded on, or otherwise be accessible from or on the Website. Please check the privacy policies or terms of service for other websites or applications.

### II. PERSONAL INFORMATION WE COLLECT

For the purposes of this Privacy Notice, "Personal Information" means any information that identifies, relates to, describes, references, is capable of being associated with, or could reasonably be linked, directly or indirectly, with an individual. When you use the Website, Personal Information may be collected directly from you (for example, when you complete our forms or enter your information on our Website), automatically as you navigate through the Website, or from third parties with whom we may collaborate to provide you with services. The Personal Information we collect depends on the context of your interactions with the Website and the choices you make, the services and features you use, your location, and applicable laws, but can include the following:

### Personal Information You Provide

- **Communication Information:** When you contact us, we may collect certain contact and other communication-related information you provide such as your name, employer name, phone number and email address. We may also collect records and copies of your correspondence (including email addresses) if you contact us, such as when you report a problem with our Website or other services.
- **Administration of Your Investment:** We may also collect certain Personal Information to assess and process your investment in Nefro and administer your investment in Nefro such as your name, address, email address, phone number, employer name, employee identification number or other professional and employment information, social security number, financial information, and tax and national identification related information.
- **Other Information:** We may also collect other Personal Information we specifically request or you voluntarily provide.

You are not required to provide us with any Personal Information that we request from you. However, failing to or refusing to provide such information may limit what we are able to do for you. For example, without your email address, we may not be able to provide you with important information about the Website.

### Information We Collect Automatically

As you navigate through and interact with the Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- **Device Information:** When you interact with and use our Website, we may receive information about your device, which may include your web browser type, operating system version, mobile device model, device manufacturer and model, language and regional settings, your Internet Service Provider (ISP), and unique device identifiers.
- **Usage Information:** We may automatically receive information about your interactions with our Website including details of your visits to our Website, traffic data, location data, logs, language, date and time of access, frequency, and other communication data and the resources that you access and use on the Website.
- **Details of referring websites (URL):** We may also use these technologies to collect information about your online activities over time and across third-party websites or other online services (behavioral tracking).
- **General Location Data:** We may infer your location from information we collect (for example, your IP address to indicate your general geographic region).

### Cookies and Other Technologies

When you use our Website, we and our third-party service providers may collect information from you through cookies, and similar technologies. Cookies are small data files that are placed on your computer or mobile device when you visit a website. Cookies are widely used by website owners to improve functionality and targeted content for visitors.

Cookies created and set by the Website owner (i.e., Nefro) are called “first-party cookies.” Cookies created and set by parties other than Nefro are called “third-party cookies.” We may use first and third-party cookies

for several reasons including improving functionality/technical purposes and assessing user traffic and success.

We may also collect information from our Website using web beacons, alone or in conjunction with cookies. Web beacons are clear electronic images that can, among other things, recognize certain types of information on your computer, such as cookies, that we may utilize to understand usage, and to operate and improve our Website and email communications.

### III. HOW WE USE YOUR PERSONAL INFORMATION

Nefro may use the information, including the Personal Information, we collect for a variety of reasons, which may include the following:

- To deliver relevant communications, including investor decks, surveys, newsletters, and other information, (which may include marketing/advertising) and measuring or analyzing success of such communication campaigns.

- To help maintain the safety, security, and integrity of our Website, and investigate and respond to suspected illegal activities or fraud.

### IV. HOW WE DISCLOSE YOUR PERSONAL INFORMATION

Nefro may disclose Personal Information that we collect or that you provide as described in this Privacy Notice to:

- **Business Entities.** We may disclose your information, including your Personal Information within the Website, to other business entities, employees and other parties who require such information to assist us with establishing, maintaining, and managing our business relationship with you.
- **Service Providers.** We may disclose your information, including your Personal Information to third-party service providers that perform services on our behalf, including to maintain, improve, and optimize our Website.
- **Merger, Sale, or Other Asset Transfers.** We may disclose your Personal Information to a potential or actual buyer or other successor in the event of a merger, divestiture, restructuring,

reorganization, dissolution, or other sale or transfer of some or all of Nefro's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which Personal Information held by Nefro about our Website users is among the assets transferred.

- **With Your Consent or Authorization.** To anyone for whom you have authorized disclosure of your Personal Information consistent with this Privacy Notice.
- **Legal Obligation.** We may use your information, including your Personal Information, to comply with any court order, law, or legal process, including to respond to any government or regulatory request. We may also use your information, including your Personal Information, if we believe disclosure is necessary or appropriate to protect and defend our rights, property, or assets.
- **Other.** We may use your information, including your Personal Information, for any other purpose disclosed by us when you provide the information or with your consent.

We may disclose deidentified or aggregated information about our Website users and information that does not identify an individual, without restriction.

## V. THIRD-PARTY COMPONENTS

Our Website may contain links, features, components or other interactive tools supplied by third parties. Please be aware that when using such third party links, features, components or other interactive tools, you are providing your Personal Information to these third parties and not to Nefro. Such third parties may have information practices different than ours and their use of cookies and similar technologies are not covered by this Privacy Notice. We do not have access to or control over such third parties and their practices and encourage you to consult their privacy notices and policies. ## VI. CHOICES ABOUT HOW WE USE AND DISCLOSE YOUR INFORMATION

We strive to provide you with choices regarding the Personal Information we collect about you. We have created the following mechanisms to provide you with control over your information:
